Final dates regarding application submission deadlines and other eligibility requirements will be included in the relevant program Notice of Funds Availability (NOFA) or Notice of Allocation Availability (NOAA), which will be published in the Federal Register.

October 11, 2006	CDFI Certification Application Deadline (for funding applicants that have not yet been certified as a CDFI).
October 11, 2006	Material Event Form Deadline (for funding applicants that are certified CDFIs or have a CDFI Certification Application currently pending with the Fund).
November 10, 2006	Last day Fund staff available to answer Application questions.
November 14, 2006	CDFI Program Application Deadline.
Summer 2007	CDFI Program Awards Announced.

### Native American CDFI Assistance (NACA) Program

September 19, 2006	NOFA published in the Federal Register.
January 26, 2007	Last day Fund staff available to answer Application questions.
January 30, 2007	CDFI Certification Application Deadline (for funding applicants that have not yet been certified as a CDFI).
