FY 2008 Native American CDFI Assistance Program (NACA) Award List

The NACA Program is designed to encourage the creation and strengthening of community-based lending organizations known as Community Development Financial Institutions (CDFIs) that primarily serve Native Communities. Native communities are defined as Native American, Alaskan Native and Native Hawaiian communities. Through the NACA Program, the CDFI Fund supports three types of entities 1) certified Native CDFIs; 2) entities proposing to become certified Native CDFIs; and 3) entities proposing to create Native CDFIs. The program is designed to build their capacity to better address the community development and capital access needs of the communities they serve. Organizations funded through the NACA Program serve a wide range of Native Communities, and reflect a diversity of institutions in various stages of development.
